- When would you date the start of China-Africa ties? With the exchange of goods/trade? With human contact? With the establishment of state-to-state ties?
- How would you periodize the history of China and Africa? What are the key facets of each period?
- How might these histories impact contemporary relations? Consider, for example, contemporary narratives/myths about Chinese slaves/prison labor, the current

- trade in endangered species/wildlife and other natural resources, or narratives of peaceful/friendly relations.
- Where are the ruptures and continuities between the past and present in China-Africa relations?
- How has China's engagement with Africa changed over the years? How have power balances shifted? What are the priorities today?
- Have rising tensions between the US and China had an impact on current ties? Are there other such examples like this in the past?

WEEK 3 (16 September):

CHINA, AFRICA, AND THE WEST: WHOSE INTERESTS? WHO BENEFITS? FRAMES, NARRATIVES, & DISCOURSES

Read 2-3 articles from this section and several general media articles about the Standard Gauge Railway controversies. (You'll have a bit more time in class to skim a few more readings.) Prepare to participate in the role play from the perspective of your "side"/based on your assigned or selected role. I want some good acting; embrace your roles/positions.

Reflection Questions:

- How has Africa changed (or not changed) since independence? What does Africa
 have to gain or lose with their partnerships with China? How much agency or
 leverage do African countries/actors have?
- Is there a China, Inc? What are China's interests in Africa? Has China become a neocolonial power in Africa? Can you identify some of the non-state Chinese actors and their interests? Can you describe an instance when state and non-state Chinese actors have differed/clashed?
- What is the common Western response to China-in-Africa? Are the West's concerns justified? With the current administration in the US and the changes taking place in Europe, how might things continue to change in the coming years?

ASSIGNMENT #1 – Position Paper OR ChatGPT paper and critique. Due 23 September.

Option one: Take a position on the statement, "China is a neocolonial actor in Africa" and support your argument with evidence based on class readings and videos. No additional research required. Max. 1,500 words.

Option two: Provide the prompt plus a few additional details (2-3 African countries and/or sectors) to ChatGPT to generate a 1,500-word essay response, then write a 1,000 – 1,500-word critique explaining whether you agree or disagree with some of the points and why. Look, in particular, for any possible biases.
